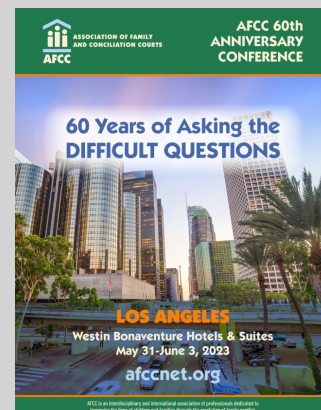

### Conversation Corner with Robert Emery

Robert Emery, PhD, will moderate the plenary session at the AFCC 60th Anniversary Conference, 60 Years of Asking Difficult Questions. Dr. Emery is

Professor of Psychology and Director of the Center for Children, Families, and the Law at the University of Virginia. He has been an active AFCC member since the early 1980s when he conducted a landmark study on mediation. He has authored over 175 scientific publications, and several books on divorce, and received AFCC's Stanley Cohen Distinguished Research Award in 2002 and served as Social Sciences Editor for Family Court Review. Dr. Emery maintains a practice as a clinical psychologist, divorce mediator, and parenting coordinator. His wife Kimberly is Assistant Dean for Pro Bono at University of Virginia Law School, and he is the father of five children.

March 13-16, and March 20-22, 2023



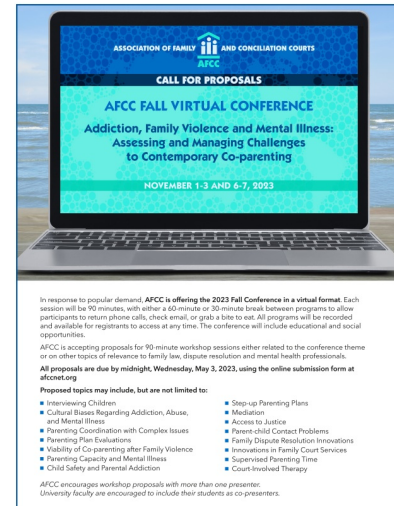

## Webinar Corner

### Coping Abilities Children Need (And How to Ensure They Get Them) Lyn Greenberg, PhD, ABPP

Tuesday, March 7, 2023

Much has been written about the direct effects of parental conflict, including long-term exposure to toxic stress and other traumatic effects. Less has been written on the devastating effect that these dynamics can have on normal child development and the child's ability to learn the critical coping abilities needed for the rest of the child's life. Parents' concerns tend to be louder and attracting of the most professional attention, which may lead to the child's needs being overlooked. Children need to learn to form healthy independent relationships, which may be all the more critical if the parents aren't functioning well. Healthy adjustment requires that they be able to accurately perceive information and interactions, separate their own feelings from those of others, manage arousal and emotional distress, accurately identify danger and appropriate ways of seeking help, focus, follow rules, master new abilities, achieve emotional independence and, in some cases, separate themselves from dysfunctional dynamics in their families. This workshop will focus on these critical coping skills and the paths through which children can attain them. Dr. Greenberg will address the challenges faced by decision-makers and parenting coordinators, as well as other legal and mental health professionals, in recognizing children in trouble and creating the circumstances that will give them a better chance at healthy development. The role of children's engagement in other systems, and appropriate selection of services, will be addressed.

**Lyn R. Greenberg, PhD, ABPP** has over 30 years' experience working with court-involved children and families. She provides parenting plan coordination, specialized treatment, consultation, training, and expert witness services. She is the lead author and editor of Evidence Informed Intervention for Court-Involved Families and has been recognized by both AFCC and the American Psychological Association for her work.
