AFCC—The next 25 years

Although AFCC's 25th Anniversary Conference is now history, the enthusiasm of the 400 conference registrants portends an exciting future for the field of family law. Long Beach conference presenters Judge Donald King, Judith Wallerstein and Professor Jay Folberg provided a look at the legal and social changes that have set the stage for the 21st century as forecasted by conference closing presenters Joan Kelly and Stephen Adams.

AFCC's future includes the development of six geographic regions encompassing the U.S., Canada, New Zealand and Australia; and regional conferences to replace the traditional December mid-winter meeting. The initial reports from the regional coordinators indicate that plans are well under way and that all six regions will be hosting a conference in the next 12 months. These regional conferences will provide an opportunity for AFCC to reach out to new members and tailor conference presentations to meet local needs.

Incoming president Judge Lawrence Kaplan's interest in membership development and the activities of AFCC's committees indicate that "AFCC is on the move!"

Over the next year, AFCC will be producing several new pamphlets and formalizing a technical assistance program to assist new courts and to enhance ongoing services provided by existing court programs.

Ann Milne, former AFCC Secretary, will become AFCC's new Executive Director, replacing Stanley Cohen, who will be retiring January 1, 1989. Dr. Cohen has served as Executive Director for the past five years. Under his direction, AFCC has grown

from a paid membership of 300 to 1,000 and has become truly international with members in Great Britain, New Zealand, Australia, Israel and Sweden.

AFCC's committees continue to be the work horses of the organization. More than 25 committees provide an opportunity for members to actively participate in the planning and development of AFCC's many activities. Committees include those that focus on specific court services, such as custody evaluation and mediation, to interest groups for each of the major dis-

ciplines that make up AFCC's interdisciplinary membership. Other committees address contemporary social issues such as family violence, public policy, and research.

The next 25 years? New issues: increased legislation directed toward family-related concerns, judicial decision making, family decision making, courts and expanded services...and AFCC continuing to provide an interdisciplinary forum for the exchange of ideas and the development of solutions to problems of family discord.

Legislative news

California

Proposed SB 1306 would rescind several critical sections of California's joint custody law. Amendments include removal of preference or rebuttable presumption for joint custody. Critics have mounted an aggressive lobby to defeat the bill and its emphasis on returning to a sole-custody concept.

Colorado

Passage of a psychotherapy licensure bill covers social workers, psychologists, marriage and family therapists and professional counselors. Although licensure is not mandatory, the law requires practitioners to be licensed in order to treat mentally ill persons, to be protected by state confidentiality laws, and to hold clients involuntarily if they are deemed to be a threat to themselves or others.

Congress

Twenty-nine countries have signed the Hague Convention of 1980 which requires that a child who is wrongfully taken or detained be returned to the nation of the child's "habitual residence." The Convention further requires that if a child is moved to another country and a parent is wrongfully denied "rights of access," the country where the child is located must enforce access rights. The U.S. will be the tenth country to implement this international agreement.

Pennsylvania

Senate Bill 409 was signed into law amending the 1980 no-fault divorce law to include reducing the waiting time for a divorce from three years to two, providing consideration of custody issues by the court at the same time as property distribution, and allowing couples to remain in the home together while meeting the standard of living separate and apart.

Wisconsin

Act 355 permits the court to order joint legal custody even when the parents do not agree and requires all counties to make mediation services available in actions affecting the family. Mediation is required in all actions where it appears that a child's legal custody or physical placement is contested. Fund-

ing for these services is provided through increases in filing fees and/or user fees. An attorney must complete three hours of approved continuing legal education training in order to be appointed as a GAL.

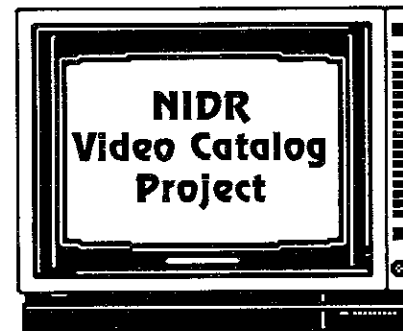
Child Find helps return children

The Child Find Mediation program is an innovative approach to solving cases of abduction in which a child is kidnapped by one of its parents. The program uses mediation as a forum for returning the child to a more stable environment. Begun in Florida in 1986, the program has assisted in the location of more than 1830 missing children. Executive Director Carolyn Zogg attended AFCC's May conference. AFCC members Patrick Phear, Michael Lang and Thomas Bishop have each mediated the return of a missing child for Child Find.

Ireland Uses Mediation

Although there is no legal means of divorce in Ireland, couples who separate need a way to address the issues of living apart. Family mediation is being used by an increasing number of couples. The Family Mediation Service of Dublin, funded by the Justice Department, has handled 600 inquiries and has begun 350 mediation cases in its first year of operation. Mediation in Ireland requires creative problem solving skills when dividing pensions and establishing maintenance and child support in a relationship that is still deemed to be legally intact.
